CEPD ANNOUNCES CONTINUED WEEKEND BEACH PARKING LOT ATTENDANTS

Captiva Erosion Prevention District (CEPD) will have continued weekend beach parking lot attendants at the Alison Hagerup Beach every Saturday and Sunday from 7:00 AM to 8:30 PM during this busy Summer season. This decision was made by the CEPD Board of Commissioners at their July 13th, 2020 regular board meeting.

Beginning Saturday, 7.18.2020 through Sunday, 8.2.2020, beach attendants will monitor and manage Alison Hagerup Beach parking lot of 40 parking spaces for cars, golf carts and motorcycles on a first come, first serve parking basis. The safe and orderly parking lot services for Captiva, provide prudent diligence for everyone.

Parking fees are paid through meters with cash and credit card; and parking tickets are not allowed to be transferable at any time. Overnight parking is not granted in this parking lot. RVs, campers, boats or trailers are not authorized to park in this parking lot. Parking fees are \$25.00 for two hours and \$40.00 for the day.

FURNITURE MUST BE REMOVED FROM BEACHES

Kindly pick up your trash and furniture from the beach; and never leave anything on the beach overnight. CEPD monitors the beaches of Captiva and will begin citing various belongings. Any personal effects seen on the beaches of Captiva that were left overnight, will be tagged with a warning for the owner to collect within 24 hours.
